**RESOLUTION**

No. IX-TTI-39/2010 8222 /I, Dtd, Bhubaneswar ୧/୫ June, 2010

The Fee Structure for Private Diploma Institutions was last time prescribed vide this Department Resolution No.9618 dated 04.07.2009 for the Academic Session 2009-10.

With a view to fix up a revised Fee Structure from the Academic Session 2010-11, Government was pleased to allow continuance of the existing Fee Structure Committee so constituted vide this Department Order No. 18052 dated 30.12.2008.

The Fee Structure Committee so constituted after thorough deliberations and examination of the financial information submitted to the Committee by different institutions has recommended the following Fee Structure for the Private Diploma Institutions for the academic session 2010-11 & 2011-12.

| (II)  | Development Fee | - | Rs. 5,800/- P.A                     |
| (III) | Caution Money   | - | Rs. 500/- P.A (One time refundable) |

Further, the Fee Structure Committee has recommended that for Government Engineering Schools/Polytechnics, the existing Fee Structure shall continue for the next two years i.e. for the academic session 2010-11 & 2011-12.

After careful consideration of the above recommendations of the Fee Structure Committee, Government have been pleased to approve the same and has decided that the said Fee Structure will be applicable only to the fresh/new students who will take admission during the academic session 2010-11, 2011-12 and the same Fee Structure can not be revised till he or she completes the course.

In addition to the above prescribed Fee Structure, the students have to pay as per actual towards cost of seat rent, electricity, water, transportation & boarding charges in the hostel.

Institutions are not allowed to charge any other fee in whatever name other than the Fee Structure prescribed above.

Any clarification to the above fee structure, if so necessary, the decision of the Government in Industries Department is final and binding for all concerned.

**ORDER:** Ordered that the resolution be published in the extra ordinary issue of Orissa Gazette for general information and copies to be forwarded to all other Departments of Government.


